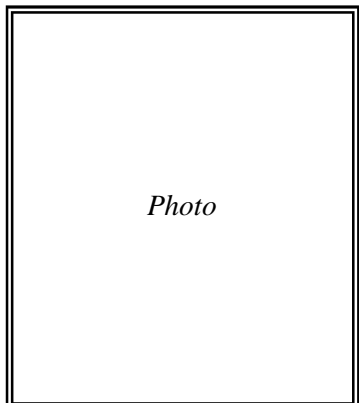

Rules & Regulations:

- The aim of this Open Bharuch English Speaking contest is to give young people practical experience in the fundamental skills of public speaking and to provide them with a focus for the learning of effective English and good communication skills.
- The registration will start from 27th September. You may download registration form from www.janmangal.co.in or from www.jcibharuch.org and can submit form in advance at, Janmangal Institute, above Geeta Khaman, College Road with prescribe registration fees. Advance registration candidates will get relieve from queue on the day of audition as they will be provided time for their audition in advance.
- By entering the Contest, you hereby warrant that all information submitted by you in your Entry is true, accurate and complete in every respect. Organizers reserves the right to verify any information contained in your Entry and/or your eligibility to enter the Contest.
- The Contest is open to persons of age group define by A, B and C. Janmangal and JCI Bharuch (organizers) assumes that by entering into the Contest, the parents or guardians of any entrant that is aged under the age of 18 have consented to that person's entry into the Contest and these Rules. Entrants is require to provide proof of identity and if aged under 18, should be able to demonstrate to organizers' satisfaction that their parent/ guardian has given their consent to such entry.
- Audition day is on 14th December from 9am to 6pm at SVMIT college. Candidates can register on the day of audition as well, provided their date of birth proof and one passport size photograph. Result (Finalist) will be declare on same day 6:00 o'clock at venue only. However, result may take some time to announce name of finalist.
- Candidates can prepare to speak about any topic out of any five topics provided over contest poster in audition round. And candidate has to speak for about 2 minutes, where first 30 seconds should contain your introduction and title of your topic on which you are going to speak. This applies for audition round.
- Final round topics will be inform to all the finalist after audition round over. Final round is on 21st Dec, Sunday from 3:00 at SVMIT venue.
- In choosing your topic, you should not be afraid to be provocative, hard hitting or humorous, as long as your intention is constructive and the speech is not offensive to anyone. However, you must avoid speeches which are likely to be perceived as doctrinal or political and should NOT use gimmicks.
- Finalist will have to prepare to answer judges questions after their speech. Questions will not be more than two or more that 3 minutes, whichever is higher.
- In any situation, judges decision will be considers as final decision in all circumstances. Decision cannot change on the basis of emotions or through any other bias rather it simply depend on individual performance only.
- No companion is allowed in audition room except sole participant. In exceptional case, it may be allow. The order of participant performance will be determine by organiser and cannot change. The use of a lectern is not allowed.
- Venue is subject to change at last minute if in case, however organizers reserved the rights of changing venue in due circumstances, declaring over websites and through sms to all registered participants.
- The right to cancel or amend all or any part of the Contest and/or the Rules without notice for any event that is outside of organizer's reasonable control. Any changes to the Rules, or cancellation of the Contest, will be posted on the Janmangal website (www.janmangal.co.in) and JCI Bharuch website (www.jcibharuch.org). It is the responsibility of entrants to keep themselves informed as to any changes to the Rules.
- In the event of any dispute regarding the Rules, the conduct or results of the Contest, or any other matter relating to a Contest, the decision of organizers shall be final and unchallengeable and no correspondence or discussion shall be entered into, comment issued, or reason given in respect of any decision made by organizers.
